Alderman Vinezeano – Not specifically to this application but where this application may lead with Bulldog's. I had a couple of businesses locally reach out that if future businesses applying for this G1 liquor license with the intention of applying for gaming, there is concern that with applying for these liquor licenses that we're saturating the market with our gaming licenses. I did have a couple of businesses reach out that have the gaming licenses already and their concern was oversaturating our market in Rolling Meadows. I just wanted to bring that up of their concerns particularly with this ordinance that's being asked.

Alderman O'Brien – I think I would second what Alderman Vinezeano said. I had the residents that are in support of the gaming is they really asked and talking to some of the current owners they are starting to get to that point and we've been down that road before with the special meetings. They're just asking us since there is not a cap on it right now that we just keep a watchful eye since it would be a third one, not this one, but a future third one in about a half mile stretch on Kirchoff. They think three is the magic number and I would defer to the experts that own these is they think that's reasonable if they wouldn't detract from each other. Even the residents are in support of it which they are from my Ward, they just want to make sure that it doesn't turn in to a whole string of gaming places. They are in support of it overall, they just want us to keep an eye on it.

Alderman Bisesi – When we were talking about this before, we had proposed three within a half mile and Council decided to say no to that ordinance. Someday maybe we will put a cap but until then I don't see any way we could cap anything.

They're good to go with the City, it's the State of Illinois that has not issued them their recreational marijuana license. There are other locations that haven't opened up either because of application issues.

Alderman O'Brien – I just learned and it's more of a public service announcement for residents, while we have no jurisdiction as a City for PACE, Manager Krumstok and I are working to get schedules put in the bus shelters. I had a phone conversation and a follow up call with one of the residents. Out of due diligence and trying to serve the residents we are going to try and put some paper copies or something as all the schedules are missing in the bus shelters. We're trying to do the best of our ability to get some type of schedule as well as direct them to PACE resources.

Mayor Gallo – I believe our PACE point of contact is pretty responsive.
