Mayor Gallo read the title into record and asked for a motion to adopt this Ordinance. Alderman O'Brien made the motion and was seconded by Alderman Sanoica.

Alderman O'Brien stated that he supports the 1% but has concerns for the longer term sustainability but knows Staff is going to look at this in 2023. He has some caution about the future and how we'll cover our costs with everything going up.

Mayor Gallo read the title into record and asked for a motion to adopt this Ordinance. Alderman Sanoica made the motion and was seconded by Alderman McHale.

E) Ordinance No. 22-52 – Amend the Rolling Meadows City Code Related to Property Tax Incentive Applications (2nd Reading)

Mayor Gallo read the title into record and asked for a motion to adopt this Ordinance. Alderman Sanoica made the motion and was seconded by Alderman McHale.

F) Ordinance No. 22-53 – Amend the Alcohol Liquor Code to Approve a Class GA liquor License for Video Gaming for Anna's Red Apple LLC dba Anna's Red Apple at 2121 Plum Grove Road (2nd Reading)

Mayor Gallo read the title into record and asked for a motion to adopt this Ordinance. Alderman McHale made the motion and was seconded by Alderman Sanoica.

Alderman Budmats made a motion to table this item for not less than 90 days to allow the applicant to bring both of his locations into compliance and was seconded by Alderman Sanoica. Council discussed concerns regarding this business owner and operations and recent inspections that have taken place for all gaming entities within the City. The applicant is in violation of items at two locations, specifically not serving food at one if his locations. Council wanted to allow at least 90 days for the applicant to come into compliance and following the rules before voting on this item.

Alderman Budmats pulled item H.

Mayor Gallo declared it in order for one motion to consider the two (2) remaining Ordinances in one motion without debate and asked for a motion to consider the Ordinances for 1st Reading. Alderman Sanoica made the motion and was seconded by Alderman Vinezeano. Mayor Gallo read the titles into record.

G) Ordinance No. 22-00 – Amend Section 122-363(1) of the Zoning Code and Section 78-27 of the City Code in order to Reduce the Number of Members of the Planning and Zoning Commission for the City of Rolling Meadows (1st Reading)

I) Ordinance No. 22-00 – Approval of the City of Rolling Meadows Compensation Plan for FY2023 (1st Reading)

With 6 in favor and 0 opposed. The Ordinances were moved forward for 2nd reading.

H) Ordinance No. 22-00 – Amend the City of Rolling Meadows Zoning Code of Ordinances to Define and Regulate "Tobacco, Vape, and CBD shops" as Permitted Uses in the C-1 and C-2 Zoning Districts (1st Reading)

Mayor Gallo read the title into record and asked for a motion to consider this Ordinance for 1st reading. Alderman O'Brien made the motion and was seconded by Alderman Vinezeano.

Council discussed the difference between a permitted use and a special use. A permitted use does not have to come before Council for approval and a special use would mean that any application must be reviewed on a case by case basis by Staff and Council prior to approval.

Alderman Budmats made a motion to direct this back to the Planning and Zoning Commission to consider changing this to a special use and other recommendations proposed by Council and was seconded by Alderman Sanoica.
