

RESOLUTION NO. 23-R-126

**A RESOLUTION AUTHORIZING THE PURCHASE AND INSTALLATION OF  
A SPRINKLER SYSTEM, RPDA BACKFLOW DEVICE, AND ALL  
ASSOCIATED PIPING, FITTINGS, AND HANGERS IN THE POLICE  
DEPARTMENT (PD) GARAGE WITH CHICAGO METROPOLITAN FIRE  
PREVENTION CO. (CMFP) IN A NOT TO EXCEED AMOUNT OF \$46,950.00**

**WHEREAS**, The City of Rolling Meadows ("City") maintains all city-owned facilities and is responsible for improvements on those facilities; and

**WHEREAS**, the City of Rolling Meadows is a home-rule community, and the City Council may waive formal bidding procedures if it determines that such action is in the best interest of its residents; and

**WHEREAS**, Chicago Metropolitan Fire Prevention Co. has completed and provided assessments to the City for the facility located at 3600 Kirchoff Road, Rolling Meadows, IL 60008; and

**WHEREAS**, Chicago Metropolitan Fire Prevention Co. provided pricing in the amount of \$48,048.87 for the facility located at 3600 Kirchoff Road, Rolling Meadows, IL 60008; and

**WHEREAS**, the 2023 FY Budget provides funding for improvements to City Facilities from Building and Land Fund (33-70-5050-60010).

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE COUNCIL OF THE CITY OF ROLLING MEADOWS, ILLINOIS**, as follows;

**Section 1. Recitals.** The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

**Section 2. Approval.** The Mayor and City Council hereby authorize the agreements and other necessary documents with Chicago Metropolitan Fire Prevention Co. in the Not to Exceed Amount of \$46,950.00 to purchase and install a Fire Sprinkler system at the Police Department garage.

**Section 3. Waiver of Competitive Bidding.** To the extent any competitive bidding requirements apply to the agreements with Chicago Metropolitan Fire Prevention Co., such competitive bidding requirements are hereby waived pursuant to section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).


**Section 4. Effective Date.** This Resolution shall be in full force and effect after its approval in the manner provided by law.


