

RESOLUTION 23-R-138

**A RESOLUTION APPROVING THE CITY OF ROLLING MEADOWS CITY COUNCIL
AND COMMITTEE OF THE WHOLE MEETING DATES FOR 2024**

WHEREAS, the City of Rolling Meadows City Code Section 2-38 sets forth that the City Council shall determine and prepare the annual schedule of all regular meetings of the City Council for such calendar year; and

WHEREAS, section 5 ILCS 120/2.03 of the Illinois Open Meetings Act (“Act”) requires that at the beginning of each calendar or fiscal year, each public body subject to the Act must at the beginning of each calendar or fiscal year, prepare and make available a schedule of all its regular meetings for such calendar or fiscal year; and

WHEREAS, in accordance with the City Code and the Act, the City Council has prepared a schedule of all regular City Council and Committee of the Whole meetings for calendar year 2024.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Rolling Meadows, Cook County, Illinois, as follows:

Section 1: The facts and statements contained in the preambles to this Resolution are found to be true and correct and are hereby adopted as part of this Resolution.

Section 2: The schedule for 2024 City Council and 2024 Committee of the Whole regular meeting dates is hereby approved as attached to this resolution as Exhibit A.

Section 3: The Deputy City Clerk is hereby directed to post and distribute the meeting schedule in accordance with City Code and the Act.

Section 4: This Resolution shall be in full force and effect immediately upon its passage and approval, as provided by law.




