

A RESOLUTION TO AUTHORIZE THE PURCHASE OF DEICING MATERIALS FROM CRYSTAL VISION, INC. FOR THE 2023/2024 WINTER SEASON IN A NOT TO EXCEED AMOUNT OF \$34,980

WHEREAS, the City of Rolling Meadows (“City”) provides snow and ice control services for the community; and

WHEREAS, the effectiveness of road salt is increased when mixed with a deicing additive; and

WHEREAS, utilizing the liquid additive reduces the total road salt used and lessens the impact on the surrounding environment; and

WHEREAS, the City has budgeted funds for the FY 2024 from the Local Road Fund 6170.5010.56260 in the amount of \$36,000; and

WHEREAS, the City has been purchasing the same product from Crystal Visions, Inc since 2008; and

WHEREAS, the City has been supplied with a quote from Crystal Visions, Inc. in the amount of \$2.65 per gallon delivered.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE COUNCIL OF THE CITY OF ROLLING MEADOWS, ILLINOIS, as follows;

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

Section 2. Approval. The Mayor and City Council hereby authorize the City Manager to enter into agreements and other necessary documents with Crystal Visions, Inc. to Authorize the Purchase of Deicing Materials from Crystal Vision, Inc. for the 2023/2024 Winter Season in a Not to Exceed Amount of \$34,980.

Section 3. Waiver of Competitive Bidding. To the extent any competitive bidding requirements apply to the agreements with Crystal Visions, Inc, such competitive bidding requirements are hereby waived pursuant to section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).

Section 4. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.


