

**AN ORDINANCE AMENDING THE CITY CODE IN ORDER
TO REDUCE THE NUMBER OF CLASS A-1 AND CLASS A-2
LIQUOR LICENSES ISSUED IN THE CITY OF ROLLING MEADOWS
(GSC Incorporated d/b/a Stadium Sports Bar & Grill – 4015 Algonquin Road and
Anna’s Red Apple LLC – 2121 Plum Grove Road)**

Whereas, paragraph (a) of Sec. 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the City Code of Rolling Meadows sets forth the total number and classification of liquor licenses to be issued by the City; and

Whereas, the recent closure and non-renewal of certain businesses in the City of Rolling Meadows, namely GSC Incorporated d/b/a Stadium Sports Bar & Grill and Anna’s Red Apple LLC, have resulted in the termination of their respective Class A-1 and Class A-2 liquor license associated with each business; and

Whereas, the City Council finds it necessary and in the best interest of the City of Rolling Meadows to amend paragraph (a) of Sec. 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the City Code to reduce the number of Class A-1 and Class A-2 liquor licenses each by one, in order to accurately reflect the current number of Class A-1 and Class A-2 licenses authorized by the City Council.

Now Therefore, Be It Ordained by the City Council of the City of Rolling Meadows, Illinois, as follows:

Section One: Paragraph (a) of Sec. 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the City Code

of Rolling Meadows is amended, in part, by revising and creating the following subparagraphs to read as follows:

(1) Eight (8) Class A-1 licenses.

(2) Fifteen (15) Class A-2 licenses.

Section Two: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.


Section Three: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.




