**A RESOLUTION AUTHORIZING THE APPLICATION FOR 2024 COOK COUNTY  
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS, AND  
CERTIFICATION OF MATCHING FUNDS AVAILABILITY**

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Rolling Meadows, Illinois, as follows:

**Section 1.** That a request is hereby made to the County of Cook, Illinois for Community Development Block Grant (“CDBG”) funds for Program Year 2024 in the amount of \$400,000 for the following project(s):

Project: Arbor Drive Phase 3 Total Project Amount: \$537,267.70

As identified in the City of Rolling Meadows’ CDBG 2024 Program Year Application.

**Section 2.** That the Mayor of the City of Rolling Meadows is hereby authorized to sign the application and various forms contained therein, make all required submissions and do all things necessary to complete the application for the funds requested in Section 1 of this Resolution, a copy of which application is on file with the Secretary.

**Section 3.** That the Mayor of the City of Rolling Meadows is hereby authorized to sign the attached Form B of the CDBG application, certifying that matching funds in the total amount of \$137,267.70, which have been identified as supporting its projects as set out within its application are or will be made available upon the approval of the projects by the County of Cook, Illinois or the prorated share thereof.



## 2024 CDBG Capital Improvement/Demolition and Economic Development Project Application

### FORM B: ESTIMATED MATCHING FUNDS CERTIFICATION

Matching funds are defined as any local, county, state, federal (other than CDBG) or private funds used in conjunction with CDBG funds to implement or construct a proposed project. This form must be filled out to document matching funds entered on the project budget (page 10-11). Please note that the use of special assessments against property owned and occupied by low- and moderate-income persons is prohibited.

In the event that the proposed project is funded at a lesser amount than requested, the matching funds will be reduced in the same proportion. For example, if you request \$100,000 with a \$30,000 (30%) match, and actually receive \$50,000 in block grant funds, your required match will be \$15,000 (30% x \$50,000).

*Subrecipients are urged to use matching funds whenever possible.*
