

ORDINANCE NO. 24-22

AN ORDINANCE AMENDING THE ALCOHOLIC LIQUOR CODE TO REDUCE THE NUMBER OF CLASS D-1 LIQUOR LICENSES AND INCREASE THE NUMBER OF CLASS B-1 LIQUOR LICENSES ISSUED IN THE CITY OF ROLLING MEADOWS (Rolling Meadows Shell Mart, Inc. – 2200 Algonquin Road)

Whereas, paragraph (a) of Sec. 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the City Code of Rolling Meadows sets forth the total number and classification of liquor licenses to be issued by the City; and

Whereas, the establishment Rolling Meadows Shell Mart, Inc. located at 2200 Algonquin Road, has requested to change their current D-1 Liquor License classification to a Class B-1 liquor license; and

Whereas, the City Council has determined that it is necessary and in the best interest of the City of Rolling Meadows to amend paragraph (a) of Sec. 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the City Code to increase the number of Class B-1 liquor licenses by one, in order to accurately reflect the current number of Class B-1 licenses authorized by the City Council.

Whereas, the City Council also finds it necessary and in the best interest of the City of Rolling Meadows to amend paragraph (a) of Sec. 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the City Code to reduce the number of Class D-1 liquor licenses by one, in order to accurately reflect the current number of Class D-1 licenses authorized by the City Council.

Now Therefore, Be it ordained by the City Council of the City of Rolling Meadows, Illinois, as follows:

Section One: Paragraph (a) of Sec. 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the City Code of Rolling Meadows is amended, in part, by revising and creating the following subparagraphs to read as follows:

5) Four (4) Class B-1 licenses.

10) One (1) Class D-1 licenses.

Section Two: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.


Section Three: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.


