

**RESOLUTION 24-R-94**

**A RESOLUTION APPROVING THE CITY OF ROLLING MEADOWS CITY COUNCIL AND COMMITTEE OF THE WHOLE MEETING DATES FOR 2025**

**WHEREAS**, in accordance with the City Code and the Act, the City Council has prepared a schedule of all regular City Council and Committee of the Whole meetings for calendar year 2025.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Rolling Meadows, Cook County, Illinois, as follows:

**Section 1:** The facts and statements contained in the preambles to this Resolution are found to be true and correct and are hereby adopted as part of this Resolution.

**Section 2:** The schedule for 2025 City Council and 2025 Committee of the Whole regular meeting dates is hereby approved as attached to this resolution as Exhibit A.

**Section 3:** The Deputy City Clerk is hereby directed to post and distribute the meeting schedule in accordance with City Code and the Act.

**Section 4:** This Resolution shall be in full force and effect immediately upon its passage and approval, as provided by law.


