



Dear Chief Nowacki,

Per our November 14, 2024, conversation, this letter confirms the Services Agreement between RedSpeed Illinois LLC ("RedSpeed") and the City of Rolling Meadows ("City") dated December 18, 2019, will expire on December 18, 2024. RedSpeed will continue maintaining and servicing the City's Automated Photo Enforcement Cameras and program administration on the same financial basis detailed in the 2019 Agreement, with all existing terms and conditions of the Agreement remaining unaltered, **except** "Exhibit A, Section 3 (Video Surveillance Solution)". The City has elected to cease utilizing the 12 installed Video Surveillance Cameras, however, requests the existing camera equipment remain in place until written notification is provided to Current Technologies regarding the proposed removal timeline. Based on RedSpeed's long standing partnership with the City, and the poor performance of the surveillance equipment over the past months, the monthly \$600 Video Surveillance Lease Fee was suspended, with no fees being applied to the City's monthly statements, effective May 1, 2024, to present.

RedSpeed proposes a continuation of this arrangement on a month-to-month basis, with the contract terminable upon 60 days written notice from either party. To reiterate, all terms and provisions of the original 2019 Agreement remain valid and binding upon both RedSpeed and the City of Rolling Meadows.

I believe this proposal will be acceptable to the City.

Looking forward to our continued partnership.
