

ORDINANCE NO. 25-11

AN ORDINANCE AMENDING SECTION 6-37 (a) OF THE CITY CODE IN ORDER TO REDUCE BY ONE AND INCREASE BY ONE THE MAXIMUM NUMBER OF CLASS A-1 LIQUOR LICENSES ISSUED IN THE CITY OF ROLLING MEADOWS

(Mirage 1 Inc. d/b/a LaMirage / IZI Lounge LLC – 3223 Algonquin Road)

WHEREAS, paragraph (a) of Section 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the Code of Ordinances, City of Rolling Meadows, Illinois, sets forth the total number and classification of liquor licenses to be issued by the City; and

WHEREAS, paragraph (b) of Section 6-37 of the Code of Ordinances, City of Rolling Meadows, Illinois, provides that “[i]f any license, of any class, is not renewed or the license is surrendered, canceled, revoked, suspended, or otherwise terminated, such license shall be rescinded and not be restored, and the total number of liquor licenses of that class to be issued by the City shall be reduced accordingly”; and

WHEREAS, the recent sale and non-renewal of a certain establishment in the City of Rolling Meadows, namely Mirage 1 Inc., d/b/a LaMirage, (“LaMirage”), which establishment was located at 3223 Algonquin Road, Rolling Meadows, Illinois, has resulted in the termination of its respective Class A-1 liquor license associated with the establishment; and

WHEREAS, the termination of the Class A-1 liquor license of La Mirage requires that the maximum number of Class A-1 liquor licenses to be issued by the City, as identified in Section 6-37(a) of the City Code, be reduced by one; and

WHEREAS, Marat Bilimbekov, Ulan Muktar and Kylychbek Abdamitov, owners of IZI Lounge LLC, are seeking a Class A-1 liquor license for their establishment located at the former LaMirage location at 3223 Algonquin Road, Rolling Meadows, Illinois; and

WHEREAS, the City Council finds it necessary and in the best interest of the City of Rolling Meadows to reduce by one (1) and then increase by one (1) the number of Class A-1 liquor licenses authorized by the City and to require that the City Code accurately reflect the current number of Class A-1 licenses authorized by the City Council.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Rolling Meadows, Illinois, as follows:

Section 1: Paragraph (a) of Section 6-37 entitled "Restriction on Number and Classification," of Article II entitled "Licenses," of Chapter 6 entitled "Alcoholic Beverages," of the Code of Ordinances, City of Rolling Meadows, Illinois, shall read as follows:

(1) Eight Class A-1 licenses.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

Section 3: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.




