

ORDINANCE NO. 25-20

AN ORDINANCE AMENDING SECTION 6-37 (a) OF THE CITY CODE IN ORDER TO REDUCE BY ONE AND INCREASE BY ONE THE MAXIMUM NUMBER OF CLASS A2 LIQUOR LICENSES ISSUED IN THE CITY OF ROLLING MEADOWS

(KKUN Enterprise Inc. d/b/a K-BBQ / Okoreat Inc. d/b/a K-BBQ
located at 1923-1925 Plum Grove Road)

WHEREAS, paragraph (a) of Section 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the Code of Ordinances, City of Rolling Meadows, Illinois, sets forth the total number and classification of liquor licenses to be issued by the City; and

WHEREAS, the recent sale of a certain establishment in the City of Rolling Meadows, namely KKUN Enterprise Inc. d/b/a K-BBQ, which establishment was located at 1923-1925 Plum Grove Road, Palatine, Illinois, has resulted in the termination of its respective Class A2 liquor license associated with the establishment; and

WHEREAS, the termination of the Class A2 liquor license of KKUN Enterprise Inc. d/b/a K-BBQ requires that the maximum number of Class A2 liquor licenses to be issued by the City, as identified in Section 6-37(a) of the City Code, be reduced by one; and

WHEREAS, Chang H. Lee, the new owner of Okoreat Inc. d/b/a K-BBQ, is seeking a Class A2 liquor license for the establishment located at 1923-1925 Plum Grove Road, Palatine, Illinois; and

WHEREAS, the City Council finds it necessary and in the best interest of the City of Rolling Meadows to reduce by one (1) and then increase by one (1) the number of Class A2 liquor licenses authorized by the City and to require that the City Code accurately reflect the current number of Class A2 licenses authorized by the City Council.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Rolling Meadows, Illinois, as follows:

Section 1: Paragraph (a) of Section 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the Code of Ordinances, City of Rolling Meadows, Illinois, shall read as follows:

(2) Fifteen (15) Class A2 licenses.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

Section 3: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.




