

ORDINANCE NO. 25-21

AN ORDINANCE AMENDING SECTION 6-37 (a) OF THE CITY CODE IN ORDER TO REDUCE BY ONE AND INCREASE BY ONE THE MAXIMUM NUMBER OF CLASS A2 LIQUOR LICENSES AND REDUCE BY ONE THE MAXIMUM NUMBER OF CLASS GA (GAMING ACCESSORY) LICENSES ISSUED IN THE CITY OF ROLLING MEADOWS

(IF Management Inc. d/b/a Jerky Jerk / Jerky Jerk Rolling Meadows LLC -
3991 Algonquin Road)

WHEREAS, paragraph (a) of Section 6-37 entitled “Restriction on Number and Classification,” of Article II entitled “Licenses,” of Chapter 6 entitled “Alcoholic Beverages,” of the Code of Ordinances, City of Rolling Meadows, Illinois, sets forth the total number and classification of liquor licenses to be issued by the City; and

WHEREAS, paragraph (b) of Section 6-37 of the Code of Ordinances, City of Rolling Meadows, Illinois, provides that “[i]f any license, of any class, is not renewed or the license is surrendered, canceled, revoked, suspended, or otherwise terminated, such license shall be rescinded and not be restored, and the total number of liquor licenses of that class to be issued by the City shall be reduced accordingly”; and

WHEREAS, the recent non-renewal of a certain establishment in the City of Rolling Meadows, IF Management Inc. d/b/a Jerky Jerk, which establishment is located at 3991 Algonquin Road, Rolling Meadows, Illinois, has resulted in the termination of its respective Class A2 liquor license and Gaming Accessory (GA) license associated with the establishment; and

WHEREAS, the termination of the Class A2 liquor license and Class GA license of IF Management Inc. d/b/a Jerky Jerk requires that the maximum number of Class A2 liquor license and Class GA license to be issued by the City, as identified in Section 6-37(a) of the City Code, be reduced by one; and

WHEREAS, Nisar Muzaffar, owner of Jerky Jerk Rolling Meadows LLC, is seeking a Class A2 liquor license for the establishment located at 3991 Algonquin Road, Rolling Meadows, Illinois; and

WHEREAS, the City Council finds it necessary and in the best interest of the City of Rolling Meadows to reduce by one (1) and then increase by one (1) the number of Class A2

liquor licenses and reduce by one (1) the number of Class GA licenses authorized by the City and to require that the City Code accurately reflect the current number of Class A2 and Class GA licenses authorized by the City Council.

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Rolling Meadows, Illinois, as follows:

Section 1: Paragraph (a) of Section 6-37 entitled "Restriction on Number and Classification," of Article II entitled "Licenses," of Chapter 6 entitled "Alcoholic Beverages," of the Code of Ordinances, City of Rolling Meadows, Illinois, shall read as follows:

(2) Fifteen (15) Class A2 licenses.

(14) One (1) Class GA license.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

Section 3: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.




