

RESOLUTION NO. 25-R-70

A RESOLUTION TO AWARD A CONTRACT TO FRANKLIN PARK PLUMBING CO. INC. FOR THE SUPPLY AND INSTALLATION OF TRENCH DRAINS AT THE PUBLIC WORKS FACILITY IN THE AMOUNT OF \$112,280.00

WHEREAS, the City of Rolling Meadows (“City”) maintains the Public Works Facility located at 3900 Berdnick Street; and

WHEREAS, the City is a home-rule unit of local government under Article VII, Section 6 of the 1970 Illinois Constitution, and the City Council may waive formal bidding procedures if it determines that such action is in the best interest of its residents; and

WHEREAS, it is in the City’s best interest to perform proactive maintenance on City facilities; and

WHEREAS, the City’s long-term Capital Program includes the replacement of trench drains at the Public Works Facility; and

WHEREAS, the City budgeted \$125,000 in FY2025 for the replacement of trench drains through the Building and Grounds Fund (33.70.5050.60010); and

WHEREAS, in accordance with the City’s purchasing policy, sealed bids were solicited, and one bid was received and publicly opened on May 27, 2025; and

WHEREAS, Tracy & Ed Construction Inc. submitted the sole bid in the amount of \$189,540, which was \$64,540 over the budgeted amount; and

WHEREAS, this bid was rejected by the City Council on June 24, 2025; and

WHEREAS, staff subsequently sought and received three proposals for the work; and

WHEREAS, Franklin Park Plumbing Co. Inc., which had not participated in the original bid, submitted a proposal in the amount of \$112,280; and

WHEREAS, the Rolling Meadows Park District will reimburse the City for 34% of the project cost (\$38,175.20).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE COUNCIL OF THE CITY OF ROLLING MEADOWS, ILLINOIS, as follows;

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

Section 2. Approval. The Mayor and City Council hereby authorize the City Manager to enter agreements and other necessary documents with Franklin Park Plumbing Co. Inc. to Replace Trench Drains at the Public Works Facility in the Amount of \$112,280.

Section 3. Waiver of Competitive Bidding. To the extent any competitive bidding requirements apply to the agreements with Franklin Park Plumbing Co. Inc., such competitive bidding requirements are hereby waived pursuant to section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).

Section 4. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.
