

**ORDINANCE NO. 24-57**

**AN ORDINANCE AMENDING THE ALCOHOLIC LIQUOR CODE  
TO APPROVE A CLASS GA LIQUOR LICENSE FOR VIDEO GAMING  
FOR JERKY JERK ROLLING MEADOWS, LLC LOCATED AT  
3991 ALGONQUIN ROAD**

**Whereas**, the Rolling Meadows Liquor Code currently provides for a Class GA (Gaming Accessory) license, which is a supplemental license that authorizes a license holder of a Class A1, Class A2, Class A3, or Class D license, in good standing, to operate on the licensed premises video gaming devices that are incidental to the primary use of the premises; and

**Whereas**, the establishment incorporated as Jerky Jerk Rolling Meadows, LLC, located at 3991 Algonquin Road, in the City of Rolling Meadows (“Jerky Jerk”), currently holds a Class A2 liquor license and is in good standing with the City of Rolling Meadows; and

**Whereas**, City staff has conducted an analysis of Jerky Jerk and has determined that the proposed video gaming use is incidental to the primary use of the establishment as a restaurant and that such establishment qualifies for a Class GA license; and

**Whereas**, the City Council desires to allow for the granting of a Class GA license for the establishment incorporated as Jerky Jerk Rolling Meadows, LLC located at 3991 Algonquin Road, in the City of Rolling Meadows.

**Now Therefore, be it ordained** by the City Council of the City of Rolling Meadows, Illinois, as follows:

**Section One:** The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

**Section Two:** That the establishment incorporated as Jerky Jerk Rolling Meadows, LLC located at 3991 Algonquin Road, in the City of Rolling Meadows, qualifies for a Class GA license and that the proposed video gaming use is incidental to the primary use of the establishment as a restaurant.

**Section Three:** That Jerky Jerk Rolling Meadows, LLC is hereby granted a Class GA liquor license and that City Council authorizes the increase of the total number of liquor licenses in that classification by one (1) to allow for the granting of this license.

**Section Four:** This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

**Section Five:** This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.
