

RESOLUTION NO. 26-R-02

A RESOLUTION TO AWARD A MULTI-YEAR CONTRACT ACCEPTING UNIT PRICES FOR FORESTRY MAINTENANCE SERVICES FOR FISCAL YEARS 2026-2028 TO R.W. HENDRICKSEN TREE CARE AT A NOT TO EXCEED AN ANNUAL PRICE OF \$82,740.00

WHEREAS, the City of Rolling Meadows (“City”) is responsible for the maintenance of over 10,000 trees on City and other public properties within the City’s jurisdiction; and

WHEREAS, the City of Rolling Meadows is a home-rule community, and the City Council may waive formal bidding procedures if it determines that such action is in the best interest of its residents; and

WHEREAS, it is in the City’s best interest to perform proactive forestry maintenance and maintain a five-year pruning cycle; and

WHEREAS, the City has budgeted funds for forestry maintenance within the General Fund budget in account #01707020-54640; and

WHEREAS, the City solicited and received proposals from contractors for a contract term of 3 years (2026-2028), with two optional one-year extensions (2029 and 2030); and

WHEREAS, R.W. Hendricksen Tree Care provided the most qualified proposal for the requested services that met all of the required specifications with a price of \$82,740.00 per year.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE COUNCIL OF THE CITY OF ROLLING MEADOWS, ILLINOIS, as follows;

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made part of this Resolution as though set forth in this Section 1.

Section 2. Approval. The Mayor and City Council hereby authorize the City Manager to enter into agreements and other necessary documents to approve a contract with R.W. Hendricksen Tree Care for forestry maintenance services for Fiscal Years 2026-2028 in the amount of \$82,740.00 annually.

Section 3. Waiver of Competitive Bidding. To the extent any competitive bidding requirements apply to the agreements with R.W. Hendricksen Tree Care, such competitive bidding requirements are hereby waived pursuant to section 8-9-1 of the Illinois Municipal Code (65 ILCS 5/8-9-1).


Section 4. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.
