

**AN ORDINANCE AMENDING APPENDIX B  
"SCHEDULE OF RATES, FEES, FINES AND PENALTIES"  
OF THE CITY OF ROLLING MEADOWS CODE OF ORDINANCES**

WHEREAS, all water bills shall be due and payable during a period of 20 days from the date of any billing;

WHEREAS, the violation of any sections of the City Code of Ordinances, Chapter 110, Utilities, the Director of Public Works has the right to turn off the water;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Rolling Meadows, as follows:

Section One: Article XXIII. Utilities of Appendix B "Schedule of Rates, Fees, Fines and Penalties" is hereby repealed and replaced with the following:

4. Fee to restore water service following turn-off for nonpayment of charges (section 110-248):

2<sup>nd</sup> Water Restoration Offense

Monday—Friday 7:30 a.m.—3:00 p.m.	\$150.00
Monday—Friday 3:01 p.m.—12:00 a.m.	\$225.00
Saturday/Sunday	\$225.00
City Holiday	\$300.00

3<sup>rd</sup> Water Restoration Offense

Monday—Friday 7:30 a.m.—3:00 p.m.	\$225.00
Monday—Friday 3:01 p.m.—12:00 a.m.	\$300.00
Saturday/Sunday	\$300.00
City Holiday	\$375.00

After the 3<sup>rd</sup> Water Restoration Offense, the water turn on fees default to the 3<sup>rd</sup> Offense Fees.

Section Two: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows, Illinois.

Section Three: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.




