

**An Ordinance Amending Chapter 6 “Alcoholic Beverages”**

**Whereas**, the City Council has determined that it is in the best interests of the city to create a new liquor license classification for the retail sale of alcoholic liquor at premises which sell motor fuel; and

**Whereas**, the City Council has determined that it is in the best interests of the city to restrict alcoholic liquor which may be sold to only beer and wine.

**Now, Therefore, Be It Ordained** by the City Council of the City of Rolling Meadows, Illinois, as follows:

**Section One:** Chapter 6, “Alcoholic Beverages” is hereby amended at Section 6-36 by adding thereto the following:

(f) (1) Class D-1 licenses shall authorize the retail sale of beer and wine only in conjunction with the sale of motor fuel, in bottles, cans or packages not to be consumed on premises where the sale of alcoholic liquor is sold within the same building as motor fuel sales are purchased.

**Section Two:** Chapter 6 “Alcoholic Beverages” Section 6-77(c) is hereby repealed.

**Section Three:** Chapter 6 “Alcoholic Beverages” is hereby amended at Section 6-77 by adding thereto, the following:

(c) It shall be lawful to sell or offer for sale at retail under a class B license, class B-1 license and D-1 license any alcoholic liquor in the city between the hours of 9:00 a.m. and 11:00 p.m. on Monday, Tuesday, Wednesday, Thursday and Friday; on Saturday between the hours of 9:00 a.m. and 12:00 midnight; and on Sunday between the hours of 11:00 a.m. and 10:00 p.m.

**Section Four:** Chapter 6, “Alcoholic Beverages” is hereby amended by adding thereto, the following:

**Sec. 6-49 Requirement for Class B-1 and D-1 licenses.**

Every class B-1 and D-1 licensee shall provide for the

following:

- a) The hours for the sale of alcoholic beverages shall be prominently posted inside of the premises.
- b) The cabinets or coolers containing alcoholic beverages shall be locked during hours when alcoholic beverages cannot be sold.
- c) Employees shall have security cameras to monitor the portion of the premises containing alcoholic beverages where those areas are not visible from the location of the cash register.

**Section Five:** Appendix B "Schedule of Rates, Fees, Fines and Penalties" is hereby amended at Article IV B by adding thereto, the following:

D-1	\$3,700.00

**Section Six:** This Ordinance shall be in full force and effect from and after its date of passage and approval as required by law.


**Section Seven:** This Ordinance shall be printed and published in pamphlet form by order of the City Council of Rolling Meadows, Illinois.




