

**AN ORDINANCE TO AMEND THE CITY OF ROLLING MEADOWS
MUNICIPAL CODE CHAPTER 106 “TRAFFIC AND VEHICLES” FOR
ADDITIONAL PARKING RESTRICTIONS**

WHEREAS, Chapter 106, “Traffic and Vehicles” Section 106-18 of the Code of Ordinances provides for parking to be prohibited in specific places on certain streets within the City; and

WHEREAS, the City Council has determined that there should be no parking on certain sides and in certain locations of various City streets, as listed below, and

WHEREAS, the City Council is of the opinion that these parking restrictions will enhance the safe flow of vehicular traffic;

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Rolling Meadows, Illinois as follows:

SECTION ONE: Chapter 106, “Traffic and Vehicles” Section 106-18 is hereby amended by adding thereto the following in its alphabetical order:

Street	Limits
<ul style="list-style-type: none"> • West Frontage Road 	<ul style="list-style-type: none"> • On the west side, from Kirchoff Road to Algonquin Road.
	<ul style="list-style-type: none"> • On the east side, from Algonquin Road to Kirchoff Road.
<ul style="list-style-type: none"> • East Frontage Road 	<ul style="list-style-type: none"> • On the west side, from Kirchoff Road to a point 75 feet south of Rywick Court
	<ul style="list-style-type: none"> • On the west side, from a point 50 feet north of Kingfisher Lane to Central Road
	<ul style="list-style-type: none"> • On the east side, from Sycamore Lane to Central Road.
	<ul style="list-style-type: none"> • On the east side, from a point at the south property line of 4202 East Frontage Road, to a point 250 feet north of the north edge of the Salt Creek bridge deck (the entrance drive to Sunset Park).
	<ul style="list-style-type: none"> • On the east side, from a point 25 feet south of the north property line of 3500 East Frontage Road, to Kirchoff Road.
<ul style="list-style-type: none"> • Plum Grove Drive 	<ul style="list-style-type: none"> • On the north side, from Magnolia Drive to Sycamore Lane.
<ul style="list-style-type: none"> • Sycamore Lane 	<ul style="list-style-type: none"> • On the east side, from Plum Grove Drive to East Frontage Road.

SECTION TWO: The no parking signs shall be in conformance with the Illinois State Manual and specifications for traffic control devices.

SECTION THREE: This ordinance shall be in full force and effect from and after its passage and approval as provided by law.


SECTION FOUR: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.




