

AN ORDINANCE PROVIDING FOR THE JURISDICTIONAL TRANSFER OF EAST AND WEST FRONTAGE ROAD BRIDGES FROM IDOT TO THE CITY OF ROLLING MEADOWS, WITHIN THE MUNICIPAL STREET SYSTEM OF THE CITY OF ROLLING MEADOWS, COOK COUNTY, ILLINOIS

WHEREAS, the City of Rolling Meadows and Illinois Department of Transportation on the date of June 8, 2010 entered into an agreement for transfer of jurisdiction of East and West Frontage Road Bridges to the Local Highway System; and

WHEREAS, the authority to enter into this contract is granted the STATE by Section 4-409 of the Illinois Highway Code and the authority to make changes in the State Highway System is granted the State under Section 2-101 of the Illinois Highway Code; and

WHEREAS, the authority to make changes to the Municipal Street System is granted to the Municipality by Section 7-101 of the Illinois Highway Code; and

WHEREAS, the corporate authority of said municipality will make a part hereof a copy of a location map as Addendum No. 1 and a copy of the ordinance as Addendum No. 2, and it is mutually agreed, that this jurisdictional transfer will become effective 21 calendar days after final inspection by the State.

NOW, THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of Rolling Meadows, State of Illinois, as follows:

Section One: That East and West Frontage Road bridges, at their crossing with Salt Creek, be transferred to the City of Rolling Meadows Municipal Street System.

Section Two: This ordinance shall be in full force and effect from and after its passage and approval as provided by law.


Section Three: This ordinance shall be printed and published in pamphlet form.






