

**AN ORDINANCE GRANTING A SPECIAL USE
(Full Potential Fitness, 3620 Edison Place)**

WHEREAS, on October 4, 2011, the Plan Commission conducted a public hearing for the purpose of considering granting a Special Use to Full Potential Fitness to permit a personal training facility for the property commonly known as 3620 Edison Place, Rolling Meadows, Illinois; and

WHEREAS, the Plan Commission conducted a public hearing on the Special Use after notice of public hearing as required by law; and

WHEREAS, the Plan Commission has submitted its report and recommendation to the Mayor and City Council of the City of Rolling Meadows; and

WHEREAS, the Plan Commission has submitted its report and recommendation to grant the Special Use to the Mayor and City Council of the City of Rolling Meadows, which report has been considered by the Mayor and City Council; and

WHEREAS, the City Council having received the minutes, recommendation and findings of fact of the Plan Commission; and

WHEREAS, the City Council finds that the evidence is such as to establish the following beyond a reasonable doubt:

That the proposed use at the particular location required is necessary or desirable to provide a service or a facility which is in the interest of public convenience and will contribute to the general welfare of the neighborhood or the community; and

That such use will not under the circumstances of the particular case, be detrimental to the health, safety, morals or general welfare of persons residing or working in the vicinity, or injurious to property values or improvements in the vicinity; and

That the proposed use will comply with the regulations and the conditions specified in the City's Comprehensive Zoning Code for such use and with the stipulations and conditions made a part of the authorization granted by the City Council.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Rolling Meadows, Illinois:

SECTION ONE: Full Potential Fitness, is hereby granted a special use pursuant to Section 122-221(c)(11) of the Comprehensive Zoning Code to permit a personal training facility for the property commonly known as 3620 Edison Avenue, Rolling Meadows, Illinois.

SECTION TWO: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows, Illinois.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.




