

**AN ORDINANCE TO AMEND THE CITY OF ROLLING MEADOWS
MUNICIPAL CODE CHAPTER 106 "TRAFFIC AND VEHICLES" FOR
ADDITIONAL PARKING RESTRICTION ON CUL-DE-SACS**

WHEREAS, Chapter 106, "Traffic and Vehicles" Section 106-24 (a) and 106-24 (b) of the Code of Ordinances provides for parking on only one side of certain streets within the City; and

WHEREAS, the City Council has determined that there should be no parking on one side of the street of the following streets:

106-24(a): Alexandra Court; south side, between Brockway Street and cul-de-sac.
Angeline Court; south side, between Benton Street and cul-de-sac.
Bent Creek Court; east and south sides, between Hartung Road and cul-de-sac.
Chapman Court; west side between Kirchoff Road and cul-de-sac.
Chas Drive; west side, between Kirchoff Road and cul-de-sac.
Colleen Court; west side, between Jody Court and cul-de-sac.
Cyndi Court; south side, between Wilke Road and cul-de-sac.
Greenwich Court; on the left hand side of the street, along the center cul-de-sac island.
Jody Court; west side, between 90 degree curve and cul-de-sac.
Lavender Court; west side, between Elizabeth Place and cul-de-sac.
Mayflower Court; west side, between Elizabeth Place and cul-de-sac.
McKone Court; south side, between California Avenue and cul-de-sac.
Peacock Court; northwest and southeast sides, between Peacock Lane and cul-de-sac;
Piper Court; north side, between Owl Drive and cul-de-sac.
Pride Court; south side, between California Street and cul-de-sac.
Redwing Court; northwest and southeast sides, between Bobwhite Lane and cul-de-sac.
Rhiannon Court; south side, between Brockway Street and cul-de-sac.
Rywick Court; north side, between East Frontage Road and cul-de-sac.
Sigwalt Court; east and west sides, from Sigwalt Street to cul-de-sac.
Stacy Court; north and south sides of the street between Fox Lane and cul-de-sac.
Theda Lane; west side, between Euclid Avenue and cul-de-sac.
Walnut Court; north and south sides, between West Frontage Road and cul-de-sac.
Williamsburg Court; north side, between Chapman Court and cul-de-sac.
Winnetka Circle; east and west sides, between Winnetka Avenue and cul-de-sac;
106-24(b): Quail Court; no parking on the hydrant side of the cul-de-sac; and

WHEREAS, the City Council is of the opinion that this parking restriction will allow for emergency response vehicle access, public services access, and vehicle safety;

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Rolling Meadows, Illinois as follows:

SECTION ONE: Chapter 106, "Traffic and Vehicles" Section 106-24 (a) and 106-24 (b) is hereby amended by adding thereto the following in its alphabetical order: 106-24(a):

Alexandra Court; south side, between Brockway Street and cul-de-sac.
Angeline Court; south side, between Benton Street and cul-de-sac.
Bent Creek Court; east and south sides, between Hartung Road and cul-de-sac.
Chapman Court; west side between Kirchoff Road and cul-de-sac.
Chas Drive; west side, between Kirchoff Road and cul-de-sac.
Colleen Court; west side, between Jody Court and cul-de-sac.
Cyndi Court; south side, between Wilke Road and cul-de-sac.
Greenwich Court; on the left hand side of the street, along the center cul-de-sac island.
Jody Court; west side, between 90 degree curve and cul-de-sac.
Lavender Court; west side, between Elizabeth Place and cul-de-sac.
Mayflower Court; west side, between Elizabeth Place and cul-de-sac.
McKone Court; south side, between California Avenue and cul-de-sac.
Peacock Court; northwest and southeast sides, between Peacock Lane and cul-de-sac;
Piper Court; north side, between Owl Drive and cul-de-sac.
Pride Court; south side, between California Street and cul-de-sac.
Redwing Court; northwest and southeast sides, between Bobwhite Lane and cul-de-sac.
Rhiannon Court; south side, between Brockway Street and cul-de-sac.
Rywick Court; north side, between East Frontage Road and cul-de-sac.
Sigwalt Court; east and west sides, from Sigwalt Street to cul-de-sac.
Stacy Court; north and south sides of the street between Fox Lane and cul-de-sac.
Theda Lane; west side, between Euclid Avenue and cul-de-sac.
Walnut Court; north and south sides, between West Frontage Road and cul-de-sac.
Williamsburg Court; north side, between Chapman Court and cul-de-sac.
Winnetka Circle; east and west sides, between Winnetka Avenue and cul-de-sac;
106-24(b): Quail Court; no parking on the hydrant side of the cul-de-sac;

SECTION TWO: The "No Parking" signs shall be in conformance with the Illinois State Manual and specifications for traffic control devices.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.


SECTION FOUR: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.


