

**AN ORDINANCE ELIMINATING THE CLASS P
LIQUOR LICENSE AND AMENDING SECTION 6-77 ENTITLED “HOURS & DAYS
OF SALE” OF ARTICLE 111 ENTITLED “SALES” OF CHAPTER 6 ENTITLED
“ALCOHOLIC BEVERAGES” OF THE CITY CODE OF
THE CITY OF ROLLING MEADOWS, COOK COUNTY, ILLINOIS**

Whereas, the City Council of the City of Rolling Meadows previously adopted legislation creating classes of liquor licenses authorizing the sale and delivery of alcoholic liquor at the retail level in the City of Rolling Meadows; and

Whereas, the City Council of the City of Rolling Meadows previously adopted legislation providing for permissive hours of sale of alcoholic liquor in the City of Rolling Meadows; and

Whereas, the City Council of the City of Rolling Meadows has determined that it is necessary and appropriate to further amend the City Code of Ordinances related to classes of liquor licenses and the permissive hours of sale of alcoholic liquor.

Now, Therefore, Be It Ordained by the City Council of the City of Rolling Meadows, Cook County, Illinois, as follows:

Section One: Section 6-36(i) of Chapter 6 “Alcoholic Beverages” is hereby repealed.

Section Two: Chapter 6 “Alcoholic Beverages” Section 6-77 entitled “Hours and Days of Sale” of Article III entitled “Sales” of Chapter 6 entitled “Alcoholic Beverages” as amended, is further amended by amending Section 6-77 (b) to read as follows:

“(b) It shall be unlawful to sell or offer to sell at retail under a Class E license, alcoholic liquor in the City on Sunday, Monday, Tuesday, Wednesday, and Thursday between the hours of 11:00 a.m. to 1:00 a.m. the following morning; on Friday from 11:00 a.m. to 2:00 a.m. Saturday morning; and on Saturday from

11:00 a.m. to 2:00 a.m. Sunday morning. On New Year's Eve, alcoholic liquor may be sold at retail until 4:00 a.m. the following morning."

Section Three: This Ordinance shall be in full force and effect from and after its date of passage and approval as required by law.

Section Four: This Ordinance shall be printed and published in pamphlet form by order of the City Council of Rolling Meadow, Illinois.




