

AN ORDINANCE AMENDING SECTION 102-60 ENTITLED “REPORT REQUIRED; PAYMENT” OF DIVISION 2 ENTITLED “HOTEL OPERATOR’S TAX” OF ARTICLE II ENTITLED “OCCUPATION TAXES’ OF CHAPTER 102 ENTITLED “TAXATION”

WHEREAS, the City of Rolling Meadows (the "City") is a home-rule unit of local government under Article VII, Section 6 of the 1970 Illinois Constitution and, except as limited by such Section, it may exercise any power and perform any function pertaining to its government and affairs;

WHEREAS, Division 2 entitled “Hotel Operator’s Tax” of Article II entitled “Occupation Taxes’ of Chapter 102 entitled “Taxation” of the Code of Ordinances, City of Rolling Meadows, Illinois, imposes a tax on persons engaged in the business of renting, leasing or letting rooms in a hotel within the City; and

WHEREAS, the City Council has determined that it is necessary, desirable and in the best interest of the City to amend the provisions of Section 102-60 entitled “Report Required; Payment” of Division 2 entitled “Hotel Operator’s Tax” of Article II entitled “Occupation Taxes’ of Chapter 102 entitled “Taxation” of the Code of Ordinances, City of Rolling Meadows, Illinois;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Rolling Meadows, Cook County, Illinois, as follows:

Section One: Section 102-60 entitled “Report Required; Payment” of Division 2 entitled “Hotel Operator’s Tax” of Article II entitled “Occupation Taxes’ of Chapter 102 entitled “Taxation” of the Code of Ordinances, City of Rolling Meadows, Illinois is hereby amended to read as follows:

Sec. 102-60. - Report required; payment.

(a) Every person engaged in the business of renting, leasing or letting rooms in a hotel within the city shall file with the city clerk, on or before the last day of each calendar month, the report to the state department of revenue required by section six of The Hotel Operators' Occupation Tax Act, 35 ILCS 145/6, approved July 6, 1961, as amended. Every person subject to the tax imposed by this division that does not file, on or before the last day of each calendar month, the report to the state department of revenue required by section six of The Hotel Operators' Occupation Tax Act, 35 ILCS 145/6, approved July 6, 1961, as amended, shall file with the city clerk, on or before the last day of each calendar month, a report of the gross rental receipts from the renting, leasing or letting rooms in a hotel within the city, excluding, however, gross receipts obtained from the renting, leasing or letting to permanent residents of the hotel in the city.

(b) At the time a copy of the report is filed with the city clerk, the person engaged in the business of renting, leasing or letting rooms in a hotel shall pay the amount of the tax required by this division.

Section Two: This ordinance shall be printed and published in pamphlet form by order of the City Council of Rolling Meadows, Illinois.

Section Three: This Ordinance shall be in full force and effect upon its passage and approval in the manner as provided by law.






