

**AN ORDINANCE OF THE CITY OF ROLLING MEADOWS, COOK COUNTY, ILLINOIS,
TERMINATING SPECIAL SERVICE AREA NO. 3 (DOC # 0614531065)**

WHEREAS, on May 9, 2006, the City Council adopted Ordinance No. 06-11 establishing Special Area No. 3 consisting of the property legally described in the attached Exhibit "A", which ordinance was recorded with the Cook County Recorder of Deeds on May 25, 2006 as Doc. No. 0614531065 and

WHEREAS, the City has collected the sum sufficient to fully satisfy the funds due the City from this Special Service Area; and

WHEREAS, the City Council desires to terminate the Special Service Area.

NOW THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF ROLLING MEADOWS, ILLINOIS, AS FOLLOWS:

SECTION ONE: That the Special Service Area No. 3 (DOC # 0614531065) for traffic signal improvements to the Marketplace shopping area is hereby terminated effective for the 2016 Tax Year.

SECTION TWO: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows, Illinois.

SECTION THREE: This Ordinance shall be in full force and effect from and after its passage and approval and publication as provided by law.



ALL OF THE MARKET PLACE OF ROLLING MEADOWS RESUBDIVISION, BEING A SUBDIVISION IN THAT PART OF THE SOUTHEAST QUARTER OF SECTION 8 AND THE SOUTHWEST QUARTER OF SECTION 9, BOTH IN TOWNSHIP 41 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS, ACCORDING TO THE PLAT THEREOF RECORDED SEPTEMBER 27, 1999 AS DOCUMENT NO. 99910798, LOTS 1 AND 3 IN M-R LOEWS THEATER COMPLEX SUBDIVISION BEING A SUBDIVISION IN THAT PART OF SAID SOUTHEAST QUARTER OF SECTION 8, ACCORDING TO THE PLAT THEREOF RECORDED DECEMBER 31, 1991 AS DOCUMENT NO. 91693565, AND ALL THAT PART OF ALGONQUIN ROAD (ILLINOIS ROUTE 62) BEING A 100.00 FOOT STRIP OF LAND IN SAID SOUTHEAST QUARTER OF SECTION 8 AND SAID SOUTHWEST QUARTER OF SECTION 9, ACCORDING TO THE PLAT THEREOF RECORDED FEBRUARY 2, 1933 AS DOCUMENT NO. 11195779, BEING DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHWEST CORNER OF SAID MARKETPLACE OF ROLLING MEADOWS RESUBDIVISION; THENCE EASTERLY ALONG THE SOUTH LINE OF SAID RESUBDIVISION SAID SOUTH LINE, ALSO BEING THE NORTHERLY LINE OF GOLF ROAD (ILLINOIS ROUTE 58 & EVANSTON - ELGIN ROAD) AS TAKEN FOR RIGHT-OF-WAY PER CONDEMNATION CASE NO. 68L13469 TO THE SOUTHEASTERLY CORNER OF SAID RESUBDIVISION; THENCE NORTHERLY ALONG THE EASTERLY LINE OF SAID RESUBDIVISION TO A ANGLE POINT IN SAID EASTERLY LINE; THENCE NORTHEASTERLY ALONG SAID EASTERLY LINE TO SECOND ANGLE POINT IN SAID EASTERLY LINE; THENCE NORTHEASTERLY ALONG SAID EASTERLY LINE TO THE NORTHEASTERLY CORNER OF SAID MARKET PLACE OF ROLLING MEADOWS RESUBDIVISION, SAID NORTHEASTERLY CORNER BEING A POINT ON THE SOUTHWESTERLY RIGHT-OF-WAY LINE OF SAID ALGONQUIN ROAD; THENCE NORTHEASTERLY ALONG A LINE MEASURED PERPENDICULAR TO SAID SOUTHWESTERLY RIGHT-OF-WAY LINE TO A POINT ON THE NORTHEASTERLY RIGHT-OF-WAY LINE OF SAID ALGONQUIN ROAD; THENCE NORTHWESTERLY ALONG SAID NORTHEASTERLY LINE OF ALGONQUIN ROAD TO A POINT OF INTERSECTION WITH THE WESTERLY LINE OF SAID LOT 3 IN THE M-R LOEWS THEATRE COMPLEX SUBDIVISION, EXTENDED NORTHEASTERLY; THENCE SOUTHWESTERLY ALONG SAID NORTHEASTERLY EXTENSION, WESTERLY LINE AND SOUTHWESTERLY EXTENSION THEREOF LOT 3, TO AN ANGLE POINT IN THE NORTHEASTERLY LINE OF SAID LOT 1 IN M-R LOEWS THEATER COMPLEX SUBDIVISION; THENCE NORTHWESTERLY ALONG SAID NORTHEASTERLY LINE OF LOT 1 TO AN ANGLE POINT IN SAID NORTHEASTERLY LINE; THENCE NORTHEASTERLY ALONG SAID NORTHEASTERLY LINE TO AN ANGLE POINT IN SAID NORTHEASTERLY LINE; THENCE WESTERLY ALONG SAID NORTHEASTERLY LINE TO A POINT ON THE WESTERLY LINE OF SAID LOT 1; THENCE SOUTHERLY ALONG SAID WESTERLY LINE TO A POINT ON THE NORTHERLY LINE OF LOT 2 IN SAID M-R LOEWS THEATER COMPLEX SUBDIVISION; THENCE EASTERLY ALONG SAID NORTHERLY LINE TO THE NORTHWEST CORNER OF SAID LOT 2; THENCE SOUTHERLY ALONG SAID EASTERLY LINE OF SAID LOT 2 TO THE SOUTHEAST

CORNER OF SAID LOT 2; THENCE WESTERLY ALONG THE SOUTHERLY LINE OF SAID LOT 2 TO A POINT ON SAID WESTERLY LINE OF LOT 1; THENCE SOUTHERLY ALONG SAID WESTERLY LINE TO AN ANGLE POINT IN SAID WESTERLY LINE; THENCE SOUTHEASTERLY ALONG SAID WESTERLY LINE TO AN ANGLE POINT IN SAID WESTERLY LINE; THENCE SOUTHERLY ALONG SAID WESTERLY LINE TO THE MOST SOUTHERLY SOUTHWEST CORNER OF SAID LOT 1; THENCE EASTERLY ALONG THE SOUTHERLY LINE OF SAID LOT 1 TO THE MOST SOUTHERLY SOUTHEAST CORNER OF SAID LOT 1, SAID SOUTHEAST CORNER BEING A POINT ON THE WESTERLY LINE OF SAID MARKET PLACE OF ROLLING MEADOWS RESUBDIVISION; THENCE SOUTHERLY ALONG SAID WESTERLY LINE TO THE POINT OF BEGINNING.
