

**A RESOLUTION AUTHORIZING THE APPLICATION FOR 2010 COOK COUNTY COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS**

**WHEREAS**, the City of Rolling Meadows has, in accordance with procedures promulgated by the Cook County Board and Department of Planning for the 2009 Cook County Community Development Block Grant Program, encouraged maximum feasible public participation in the development of applications for the program by taking the following actions:

- 1) Publication of a Notice of Public Hearings on previous CDBG projects and potential projects and activities for future CDBG applications, as necessary and required, was made in the Daily Herald in November and December 2009.
- 2) Public Hearings soliciting community input were held at the January 12, 2010 and January 26, 2010 City Council meetings.
- 3) Publication of a Notice of Public Hearing on prospective applications and Five-Year Consolidated Plan was made in the Daily Herald newspaper on January 8, 2010.
- 4) A Public Hearing regarding these projects was held at the February 9, 2010 City Council meeting; and

**WHEREAS**, the City of Rolling Meadows, Illinois has developed a plan that addresses development related needs to improve the local community, its housing, its infrastructure, and its local tax base, and said plan was previously adopted by the City Council of the City of Rolling Meadows, Illinois; and

**WHEREAS**, applications have been received, evaluated within the context of the plan, and been recommended to the City Council by the Public Works Director and the City Manager as being qualified for consideration under the 2010 Cook County Community Development Block Grant program.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Rolling Meadows as follows:

**SECTION ONE:** That a Request is hereby made to the County of Cook, Illinois for Community Development Block Grant (“CDBG”) funds for Program Year 2010 in the amount of \$70,000 for the following project:

**SECTION TWO:** The Mayor and the City Clerk are hereby authorized to sign the application and various forms contained therein, make all required submissions, and take all necessary actions to make application for the funds requested in Section One of this Resolution, a copy of which application is on file with the City Clerk.


