

**A RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT FOR

STORM SEWER REHABILITATION PROGRAM**

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Rolling Meadows, Illinois, that a contract for Professional Engineering Services, including the preparation of construction plans and specifications, bid assistance, and “as needed” construction observation for the FY2012 Sanitary Sewer Rehabilitation Program, consisting of point/short lining of pipes and manhole to manhole pipe lining, sanitary sewer and storm sewer manhole rehabilitation, and storm sewer pipe grating, be awarded to RJN Group, Inc., located at 200 West Front Street, Wheaton, Illinois 60187, in an amount not to exceed \$29,185, per the proposal dated February 7, 2012 (copy attached).





### **Proposed Project Scope of Work**


1. Assisting in preparation of lining proposals, including exhibits, proposal documents, review of proposals, recommendation letter, Contract, part-time resident engineering as requested by City, and update to GIS sanitary sewer layer.
2. Assist in the procurement of manhole rehabilitation services, including exhibits, proposal documents, invitation and communication with Contractors, review of proposals, recommendation letter, Contract, part-time resident engineering as requested by City and update to GIS manhole rehabilitation layer.

3. Assist in the procurement of storm sewer grouting services, including exhibits, proposal documents, invitation and communication with Contractors, review of proposals, recommendation letter, and Contract preparation.
4. Update GIS manhole layer to separate repair types into individual layers. Provide additional GIS updates of the sanitary layer as requested within budget constraints.

The work will be invoiced on a time and material basis, based on the attached Fee Schedule not to exceed **\$30,000**. Individual projects will be budgeted and approval obtained from the Department of Public works prior to execution. A breakdown of the anticipated project costs is enclosed. A schedule will be determined at the time each individual project is approved. All work will be completed by December 31, 2012.
