

**A RESOLUTION AUTHORIZING THE CERTIFICATION OF MATCHING FUNDS  
AVAILABILITY FOR THE 2019 COOK COUNTY COMMUNITY DEVELOPMENT  
BLOCK GRANT PROGRAM**

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Rolling Meadows, Illinois, as follows:

**Section 1.** That a Request is hereby made to the County of Cook, Illinois for Community Development Block Grant ("CDBG") funds for Program Year 2019 in the amount of \$400,000 for the following project(s):

Project: Arbor Drive – Watermain Replacement and Roadway Resurfacing  
Amount: \$400,000 as identified in Municipality's CDBG 2018 Program Year application, for roadway resurfacing of Arbor Drive (Phase I). The local match for this project is the watermain replacement, also estimated at a cost of \$400,000 (Phase I).

**Section 2.** That the Mayor of the City of Rolling Meadows is hereby authorized to sign the application and various forms contained therein, make all required submissions and do all things necessary to complete the application for the funds requested in Section 1 of this Resolution, a copy of which application is on file with the Secretary.




