

**AN ORDINANCE AMENDING THE ALCOHOLIC LIQUOR CODE
TO APPROVE A CLASS GA LIQUOR LICENSE FOR VIDEO GAMING FOR
IF MANAGEMENT INC. DBA PICANTE MEXICAN BAR AND GRILL
LOCATED AT 3989 ALGONQUIN ROAD, ROLLING MEADOWS**

Whereas, the Rolling Meadows Liquor Code currently provides for a Class GA (Gaming Accessory) license, which is a supplemental license that authorizes a license holder of a Class A1, Class A2, Class A3, or Class D license, in good standing, to operate on the licensed premises video gaming devices that are incidental to the primary use of the premises; and

Whereas, the establishment incorporated as IF Management Inc., and doing business as Picante Mexican Bar and Grill located at 3989 Algonquin Road, in the City of Rolling Meadows (“Picante”), currently holds a Class A2 liquor license and is in good standing with the City of Rolling Meadows; and

Whereas, City staff has conducted an analysis of Picante and has determined that the proposed video gaming use is incidental to the primary use of the establishment as a restaurant and that such establishment qualifies for a GA license; and

Whereas, City staff has prepared a written report detailing the information and findings that Picante qualifies to operate video gaming under a GA license and such report has been approved by the City Manager and the Mayor, as the Local Liquor Commissioner, and presented to the City Council; and

Whereas, the City Council desires to allow for the granting of a GA license for the establishment incorporated as IF Management Inc., and doing business as Picante Mexican Bar and Grill located at 3989 Algonquin Road, in the City of Rolling Meadows.

Now Therefore, Be it ordained by the City Council of the City of Rolling Meadows, Illinois, as follows:

Section One: The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section Two: That the establishment incorporated as IF Management Inc., and doing business as Picante Mexican Bar and Grill, located at 3989 Algonquin Road in the City of Rolling Meadows (“Picante”), qualifies for a GA license and that the proposed video gaming use is incidental to the primary use of the establishment as a restaurant.

Section Three: That Picante is hereby granted a class GA liquor license, said license to be provided by City staff only after Picante secures from the City a certificate of completion for interior building modifications associated with the GA license and that City Council authorizes the increase of the total number of liquor licenses in that classification by one (1) to allow for the granting of this license.

Section Four: The Mayor, as Liquor Commissioner, and the City Manager will continue to monitor the operations of Picante to ensure that the establishment operates video gaming devices that are incidental to the primary use of the premises and remains qualified to hold a GA license.

Section Five: If at any time it is determined that Picante is primarily operating its establishment as a video gaming café under the criteria set forth in Section 6-34(12) of the City Code, the GA license granted herein will be subject to revocation and all video gaming devices must be disengaged until such time the establishment holds a valid license to operate video gaming.

Section Six: This Ordinance shall be in full force and effect from and after its passage

and approval as provided by law.


Section Seven: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.


