

AN ORDINANCE TO AMEND LIQUOR LICENSES CLASSIFICATIONS FOLLOWING PASSAGE AND COMPLETION OF ORDINANCE 20-31 AS APPROVED ON AUGUST 11, 2020 PERTAINING TO "ALCOHOL BEVERAGES" AND TO EXTEND ANNUAL LICENSE FEE DUE DATE FOR VIDEO GAMING TERMINALS

Whereas, on August 11, 2020, the City Council adopted Ordinance No. 20-31, that amended the regulations and liquor license categories for establishments within the City that maintain video gaming; and

Whereas, in accordance with Ordinance No. 20-31, the City Manager, or his designee, has determined and prepared a report regarding whether the renewal license classification, to be applied January 1, 2021, for those establishments that maintain video gaming are to be designated as a class GA license or a class GC license, with such report having been submitted and approved by the Mayor as the Local Liquor Commissioner; and

Whereas, the City Council finds it necessary and in the best interest of the City of Rolling Meadows to amend Section 6-37 of the City Code to count for and accurately categorize the liquor licenses in the GA and/or GC classification for current liquor license holders that maintain video gaming within their establishments.

Now Therefore, Be It Ordained by the City Council of the City of Rolling Meadows, Illinois, as follows:

Section One: Paragraph (a) of Sec. 6-37 entitled "Restriction on Number and Classification," of Article II entitled "Licenses," of Chapter 6 entitled "Alcoholic Beverages," is amended, in part, by revising and creating the following subparagraphs to read as follows:

- (2) Fifteen Class A2 Licenses
- (11) ~~Class G1 Licenses~~ (License classification eliminated effective Jan. 1, 2021, by Ordinance No. 20-31)

(15) Seven Class GA Licenses

(16) Four Class GC Licenses

Section Two: The deadline for payment of the 2021 annual license fees for video gaming terminals and terminal operators, as set forth in Section XXVII entitled "Video gaming" of Appendix B entitled "Schedule of Rates, Fees, Fines and Penalties," shall be extended to June of 2021.

Section Three: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.


Section Four: This Ordinance shall be printed and published in pamphlet form by order of the City Council of the City of Rolling Meadows.


