

**A RESOLUTION AUTHORIZING A CONSTRUCTION CONTRACT WITH
LENNY HOFFMAN EXCAVATING FOR WATER MAIN REPLACEMENT AT
3000 KIRCHOFF ROAD, BEHIND THE ROLLING MEADOWS SHOPPING
CENTER IN AN AMOUNT OF \$313,154.00**

WHEREAS, the City of Rolling Meadows (“City”) maintains a water distribution network; and

WHEREAS, the City is a home-rule unit of local government under Article VII, Section 6 of the 1970 Illinois Constitution and, except as limited by such section, it may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, City staff recommends utilizing Lenny Hoffman Excavating to complete the water main project as they are on-site performing the Park Street storm sewer improvements, no additional mobilization costs are needed; and

WHEREAS, Lenny Hoffman Excavating located at 3636 E Lake Ave, Wilmette, IL 60091 has submitted a proposal for the installation of (952) nine hundred and fifty-two linear feet of (8) eight-inch water main behind the Jewel Shopping Center located at 3000 Kirchoff Road not to exceed \$313,164.00; and

WHEREAS, funds are available utilizing ARPA Parallel Funding from the Utilities Account (20-70-5030-60020).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE COUNCIL OF THE CITY OF ROLLING MEADOWS, ILLINOIS, as follows;

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in this Section 1.

Section 2. Approval. The Mayor and City Council hereby authorize the agreements and other necessary documents with Lenny Hoffman Excavating in an amount of \$313,164, for the replacement of approximately 952 linear feet of water main behind the Jewel Shopping Center located at 3000 Kirchoff Road.

Section 3. Waiver of Competitive Bidding. To the extent, any competitive bidding requirements apply to the proposal with Lenny Hoffman Excavating, such competitive bidding requirements are hereby waived pursuant to Section 8-9-1 of the Illinois Municipal Code (65 ILCA 5/8-9-1).

Section 4. Effective Date. This Resolution shall be in full force and effect after its approval in the manner provided by law.

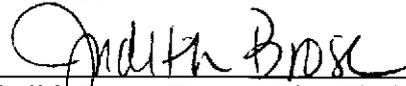
